1. USRA rules apply, unless otherwise noted.
2. MATCHES - best 2 out of 3 games.
 First two games to 15 points. Third game, if necessary, to 11 points.
Consolation matches - one game to 21 points.
3. If playing 3 events, NO TIME EXCEPTIONS.
4. Approved (USRA) eyeguards are required.
5. CHECK-IN 30 minutes prior to every match.
6. REFEREE – losers or suitable replacement.
7. TIME EXCEPTIONS – must be in writing before the entry deadline. If the tournament cannot honor your request, entry/fees will be sent back. Scheduling changes will not be made after draws are completed.
8. NO REFUNDS after tournament deadline.
9. TOURNAMENT DIRECTOR has the right to combine or cancel an event, if not enough players in those divisions. We reserve the right to combine divisions with less than 6 players. Players will be notified of changes. Director will notify players of any changes. We reserve the right to combine divisions, if less than 6 players.
10. NO outside alcoholic beverages may be consumed on the premises.
11. CHILDREN – for the safety and well being of everyone, children 14 & under, must be supervised by an adult at all times. Check club playroom for hours.
12. PLAYER CODE of CONDUCT – must be followed at all times or you may be forfeited from the tournament.
