### Conditions of Play

1. All participants must be current members of the USAR. If you are not a member, please include a check in the amount of \$50 (\$25 for 21 & under) for your annual membership fee or \$20 for this tournament only. Your USAR membership fee must be paid prior to your first match.
2. USAR rules apply to all matches unless otherwise noted.
3. A match will consist of two games to 15 points, tiebreaker to 11 points. All consolation matches, including finals, are one game to 21 points, including finals.
4. Third event must be mixed.
5. All players must be ready to play thirty minutes prior to their scheduled match time.
6. All losers must referee after each loss or find a suitable replacement. If a player loses a match and does not report to referee, they will be forfeited out of their next match and will lose all ranking points earned in that division for that tournament.
7. Requests for special time considerations must be in writing before the entry deadline. We will try to honor requests. If we cannot accommodate your time requests, we will send back your entry fee.
8. No refunds after tournament entry deadline.
9. USAR approved Lensed Eyeguards are mandatory. For a complete list go to [www.usra.org](http://www.usra.org).
10. The tournament director reserves the right to combine or cancel an event and will notify players of changes.
11. Please abide by the Rules and Regulations of the Club and the ORA Player Code of Conduct or risk being forfeited from the event. ANY BEHAVIOR DEEMED INAPPROPRIATE BY THE TOURNAMENT DIRECTOR WILL RESULT IN THE PLAYER BEING REMOVED FROM THE TOURNAMENT.
