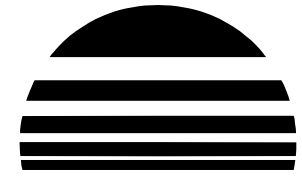

4. Gold round matches and finals: 2 games to 15, tiebreaker to 11. Other matches 1 game to 21.
5. Multi-bounce games to 9, tiebreaker to 7.
6. All winners must report to the tournament desk immediately after their match to referee or forfeit.
7. Submit all time requests in writing. No special request will be honored after draw is complete.
8. The tournament director reserves the right to advance or delay the starting time of the match.
9. Double players can only participate in the division of the upper level player.
10. Players are required to check in at the tournament desk 60 minutes before each match is scheduled to start. Ten-minute late forfeiture time will be enforced.
11. The tournament director reserves the right to combine levels, and have 'round robin' play if under 7 players
